

**INSURANCE POLICY  
LAWYERS' PROFESSIONAL LIABILITY

This Policy is issued by the Insurer - **AlfaStrakhovanie PLC** in confirmation of the terms of the Insurance Contract No. 0311Z/761/50001/25 (further – "Insurance Contract"), of which it is an integral part, acts in accordance with the Insurance Contract and the "Rules of Lawyers' Professional Liability Insurance" approved by the Insurer on April 7, 2015 (further – "Insurance Rules") that are attached to this Policy and are an integral part of it.

**Subject of Insurance:** is the property interests of the Insured (Individuals whose liability is insured), related to:  
(a) the risk of liability claims occurrence for harming the property interests of Beneficiaries as a result of insured activities;  
b) the risk of unforeseen litigation and other costs of the Insured (Individuals whose liability is insured), related to the asserted claims (lawsuits, complaints) for compensation of damages, the risk of occurrence of liability for which is insured under the Insurance Contract.

**Insurance cases** are the events covered under section 3.1.2 of the Insurance Rules, provided for in section 2.2. of the Insurance Contract, which cause an obligation of the Insurer to make an insurance payment to the Beneficiaries whose property interests are harmed as a result of the insured activity of the Insured (Individuals whose liability is insured) and which resulted in the obligation of the Insurer to pay the insurance reimbursement.  
Insurance case is the occurrence of unforeseen litigation and other costs of the Insured (Individuals whose liability is insured) related to the asserted claims (lawsuits, complaints) for compensation of damages, the risk of occurrence of liability for which is insured provided that:

- such costs have been agreed with the Insurer in writing.
- such costs were held in order to reject claims (lawsuits, complaints) for damages or to reduce the amount of reimbursement

**Sum Insured:** Sum Insured for all Insurance cases: 20,000,000.00 (Twenty million and 00/100) rubles  
The liability limit for one Insurance case is 5,000,000.00 (Five million and 00/100) rubles.  
60,000.00 (Sixty thousand and 00/100) rubles for each Insurance case.

**Deductible:**

**Period of Insurance:** The Insurance Contract comes into force on May 1, 2025 and is valid until April 30, 2026.  
Both dates included.

The Insurance Contract covers only lawsuits or claims made in regard of the Insured during the term of the Insurance Contract for errors made by the Insured between May 1, 2015 and until the April 30, 2026.
